Clear & Objective Advice to Help You Overcome the Pitfalls of Separation

The breakdown of all relationships, whether you are married or not, involves many issues which need to be rapidly addressed. Our lawyers can give clear and objective advice in order that our clients become aware of their rights and all the possible pitfalls at an early stage. As the law currently stands, the protection given to married couples is not given to couples living together. It is always best to protect against the possibility of the breakdown of a relationship even though it is hoped that our advice will never need to be acted upon.

If a married person is of the opinion that there is no hope of saving the marriage it may be best to follow divorce or judicial separation proceedings to bring an end to the marriage. Divorce proceedings give the parties the ability to apply to the court for property, money or maintenance orders. A divorce means that when a decree absolute is granted, the parties are no longer husband and wife. For religious reasons some people still wish to be married but need to be able to apply to the court for orders in respect of financial issues. A judicial separation petition may then be appropriate.

Arrangements can also be made for you to be put in touch with a **Mediation Service** whose aim is to help divorcing or separating couples to settle their own problems arising from the breakdown of their relationship, especially in respect of children and financial issues.

An Impartial Approach to Resolve Issues with Children in a Separation

Children are very often the casualties of marital breakdown. Who should look after them, where should they live and how much contact should the other party have, are uppermost in the thoughts of the parents. These are the most difficult issues for a parent to resolve as they will both still carry the same responsibilities for their children. These issues are often contested, sometimes for the wrong reasons, and emotions run very high. It is important that our clients reach the right conclusion with the minimum of upset.



Experience is Paramount to Resolving Difficult Financial Issues

Financial decisions made by a court are perhaps the single most important issue in all cases of family breakdown and will invariably affect the future financial well being of our clients. Financial issues that may be considered include:

- The place the parties will live

There are many other examples but everything depends upon the circumstances of the case. Helping Provide Immediate Protection in Domestic Violence Cases

Very often violence is ongoing and it is important that decisions are taken and acted upon quickly. **We offer a rapid, no nonsense approach.** An order can often be obtained on the day of taking instructions or within 24 hours, providing immediate protection for the client and in some circumstances the protection of the police. Put Your Mind At Ease About Costs

An initial meeting may be undertaken on a no-obligation basis and means if a client does not want to proceed further it will not cost them anything.
